TideLine Greens was founded for two primary reasons; to provide the students of Harpswell Coastal Academy with healthy, nutritious, local food on a daily basis and to increase general access to fresh, healthy produce in Harpswell.

In keeping with our mission, we are pleased this year to once again offer farm shares in collaboration with Two Coves Farm. Shareholders will receive a weekly bounty of fresh vegetables and herbs, from June 15 through September 22.

Salad shares are pre-portioned boxes that consist of a seasonal variety of salad greens and vegetables. Salad shares provide enough produce for a weeks worth of salad for a household of 2 or 3.

Full shares are pre-portioned boxes that consist of a seasonal variety of vegetables. Full shares provide enough produce for a household of 2 or 3.

Market shares operate on a 'mix and match' system. Rather than receiving a pre-portioned box, you are able to choose from the weeks offerings.

Market shares provide enough vegetables for a household of 3 or 4.

Market shares are available for pickup at Two Coves Farm only.

By purchasing a farm share with TideLine Greens you are investing in the future of our community while helping to preserve the working farmscape of rural Harpswell.
